Gazette 1476 B'/17-04-2020) for the implementation of temporary measures applicable to all persons coming from abroad including workers in international transport (by air, sea, road) to remain indoors for 14 days (quarantine) and in order to protect your health, you need to complete this form.

According to Decision No $\Delta 1\alpha/\Gamma\Pi$.oux.22261 dated on 2nd April 2020 (Gov. Gazette 1127 B''), as it has been modified by Joint Ministerial Decision No. $\Delta 1\alpha/\Gamma\Pi$.oux.25773 (Gov. Gazette 1476 B'/17-04-2020) temporary measure is implemented to all persons coming from abroad by any means of transport (including countries member of the EU) dated upon their arrival to remain indoors for 14 days (quarantine), for public health purposes and in order to prevent further expansionu of COVID-19 into Greek territory.

The implementation of the restriction measures refers to persons entering the country during the period from 2.4.2020 from 12:00 until 15.5.2020 to 12:00.

Persons who lack of permanent residence in Greece are obliged to remain, for the abovementioned period of time, at the place declared as temporary residence such as residence of a relative or family member or hotel address, unless they remain in Greece for less period of time. In that case the temporary restriction lasts for the time spent in Greece.

Authorities as well as monitoring officials for the implementation of immediate measures taken for the prevention of further expansion of COVID-19, according to article 23 of the Greek Government's Decision on 14th .03.2020 (A' 64) <u>are provided with all necessary information, according the legislation referring to Personal Data Information</u> <u>Protection.</u>

Authorities as well as monitoring officials may ask from the persons mentioned in paragraph 1. when entering the country, the address stated where they will remain for the next fourteen (14) days in guarantine.

Those violating the measures decided and mentioned above, are imposed with a justified decision of the relevant Authority according to article 23 par.1. (a) of the Greek Government's Decision on 14th .03.2020 (A' 64) a fine of five thousand euro (5.000) taking also into account the subsidiary legal sanctions.

WORKING PERSONNEL IN INTERNATIONAL AIR, SEA AND ROAD MEANS OF TRANSPORTATION

People working in international air, sea and road transportation, regardless of citizenship, are obliged after entering the country, without delay either to cross the country and exit or to head to their destination and remain indoors for fourteen (14) days quarantine according to the first article of the Joint Ministerial Decision No. $\Delta 1\alpha/\Gamma\Pi.oux.22261$ on 2nd April 2020 (Δ EK 1127 B'), as it has been modified by Joint Ministerial Decision No. $\Delta 1\alpha/\Gamma\Pi.oux.25773$ (Gov. Gazette 1476 B'/17-04-2020).

In case of mandatory requirement to conduct a new international journey by the workers mentioned in paragraph above. within the period of fourteen days restriction, the restriction is lifted. In case of mandatory requirement for those workers to conduct within the period of fourteen days restriction a new internal journey (within Greek territory) the restriction is lifted only when seven (7) days of self guarantine have been completed.

In any case, the persons mentioned above, should for the time being in Greece follow all exceptional measures taken for the prevention of the expansion of COVID-19.
